BSI will provide a technical file review to ensure:

- Evidence of PAS 24 testing
- Comprehensive component list
- Assembly drawings
- Declaration of contents accuracy

The verification certificate will be valid for one year. At renewal you'll be required to declare any changes to the technical file (which will result in a new certificate being issued) or if there are no changes you can apply for an extension which will last an additional year.
