The BSI Kitemark is a mark of quality, safety and trust, increasingly used for lighting products in overseas markets. The scheme encompasses type testing, a review of technical documentation, an initial and thereafter annual factory inspection, certification and audit testing. As a Level 5 certification scheme, products bearing the BSI Kitemark have been tested on an ongoing basis, over and above the minimum legal requirements, to ensure standards do not slip over time. This robust process demonstrates a firm and ongoing commitment to product quality and safety.

BSI now offers Kitemark Schemes for Luminaires, Commercial Lighting, Self-ballasted LED Lamps and Emergency Lighting.

The BSI Kitemark is not just recognized and demanded in the UK; it has high levels of global recognition, increasingly in regions such as the Middle East.

CE Marking



CE marking allows manufacturers to legally market and distribute their products within the European Market, and declares that products comply with all applicable European Directives and

Regulations. As a Notified Body, BSI can help manufacturers gain access to the European market by ensuring products meet all CE marking requirements. We work in partnership with manufacturers to help them understand and comply to the essential requirements, enabling them to confidently and legally affix CE marking to their products.

The ENEC European Certification Scheme



BSI is a member of the ENEC European Certification scheme for lighting, administered by the European Testing and Inspection Certification System (ETICS), widely recognized and demanded throughout Europe within the electrical product sector, especially in the area of public sector procurement. ENEC Certification, like the BSI Kitemark, is a Level 5 certification scheme so manufacturers are audited annually. This scheme helps manufacturers enhance their reputation in an industry where performance and reliability are critical to ensure safety. We can also help manufacturers gain international approvals, so they can make the most of opportunities to sell into new markets and grow their business.

The International IECEE CB (Certification Bodies) Scheme



We are also a member of the internationally recognized CB Scheme offered by the IECEE for electrical and electronic equipment, which can give lighting manufacturers widespread access to other markets around the world, based on local product evaluation. The scheme is widely adopted with +400 testing laboratories and Certification Bodies in +50 countries located across America, Europe, Asia, Australasia and Africa. CB Certificates are also often accepted in non-member countries, providing further opportunities to enter new markets.

The Emirates Conformity Assessment Scheme



BSI is a notified body for the Emirates Authority for Standardization and Metrology (ESMA), meaning that BSI is authorised to issue Emirates Conformity Assessment Scheme (ECAS) certificates and the Emirates Quality Mark (EQM) for imported products on their behalf. Alongside the G Mark, ECAS certification is a legal requirement for products imported into the United Arab Emirates. The ECAS scheme means BSI can certify a range of products, including low voltage equipment (LVE) and general lighting. Acceptance of products into the scheme is based on testing and certification conducted under the IECEE CB Scheme. Manufacturers who hold IECEE CB certification can apply for a certificate of conformity, valid for a period of one year, after which they are required to reapply.

Dubai Civil Defence



In addition to the above schemes, the Dubai Civil Defence has named BSI as an approved laboratory and Certification Body for emergency lighting luminaires, auto test systems and central battery systems. The BSI Kitemark is one of a small number of Certification Marks accepted in this region.
