What is PAS 2060?

PAS 2060 is the internationally applicable specification for the demonstration of carbon neutrality. This standard substantiates any claims you make that your business is carbon neutral, allowing you to improve your environmental credentials through accuracy and transparency.

What is carbon neutrality?

Carbon neutrality means not adding new greenhouse gas (GHG) emissions to the atmosphere. Where emissions continue, they will be offset by absorbing an equivalent amount from the atmosphere, for example through carbon capture and reforestation supported by carbon credit schemes.

Why does it matter?

Carbon neutrality is important because increasing levels of GHGs, of which carbon is the most common, contribute to harmful global warming and climate change. Scientists overwhelmingly agree that, if no action is taken, the world's temperature could increase by up to 5° by 2100, with catastrophic consequences.

What does carbon neutrality mean for your business?

Governments are increasingly insisting on carbon neutrality. The UK government, for example, has set a target for all businesses to become carbon neutral – or achieve 'net zero' GHG emissions – by 2050. In addition, carbon neutrality is a key objective for organizations wishing to help combat climate change, enhance their sustainability credentials, support the United Nations Sustainable Development Goals (UNSDGs), and offer customers greener products and services.

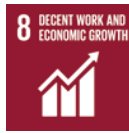
- **Quantification** of GHG emissions based on accurate measurement data
- **Reduction** of emissions through a target-driven carbon management plan
- **Offsetting** of residual emissions, through the purchase of carbon credits
- **Documentation** and assurance through qualifying explanatory statements and public disclosure.
