What does a BSI Kitemark for window installations mean?

Based on the British Standard, BS 8213-4, (Windows, doors and rooflights. Code of practice for the survey and installation of windows and external doorsets), the BSI Kitemark for window and door installation is an independent mark of quality, and proves that installation of windows or door have met critical quality requirements, not just Building Regulations Compliance. It includes:

- **Design** – ensuring windows and doors are correct for intended use
- **Surveying** – risk assessment, correct selection of door and window size, design and function
- **Installation practice** – including the safe removal of old windows and doors
- **Staff training** – all staff are properly trained and competent
- **Property care** – to avoid damage to furniture and floor coverings
- **Building regulations compliance** – including fire, thermal efficiency and safety glazing
- **Material quality** – all materials must meet the required quality standards
- **Inspection** – installations are checked to see that they have been installed to meet the requirements of the British Standard, BS 8213-4 and the system designer recommendations.

What can the BSI Kitemark do for you
