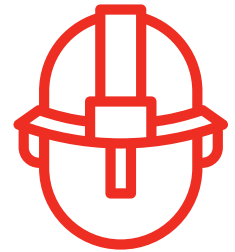

### Bringing health and safety and continuous improvement into the heart of your business

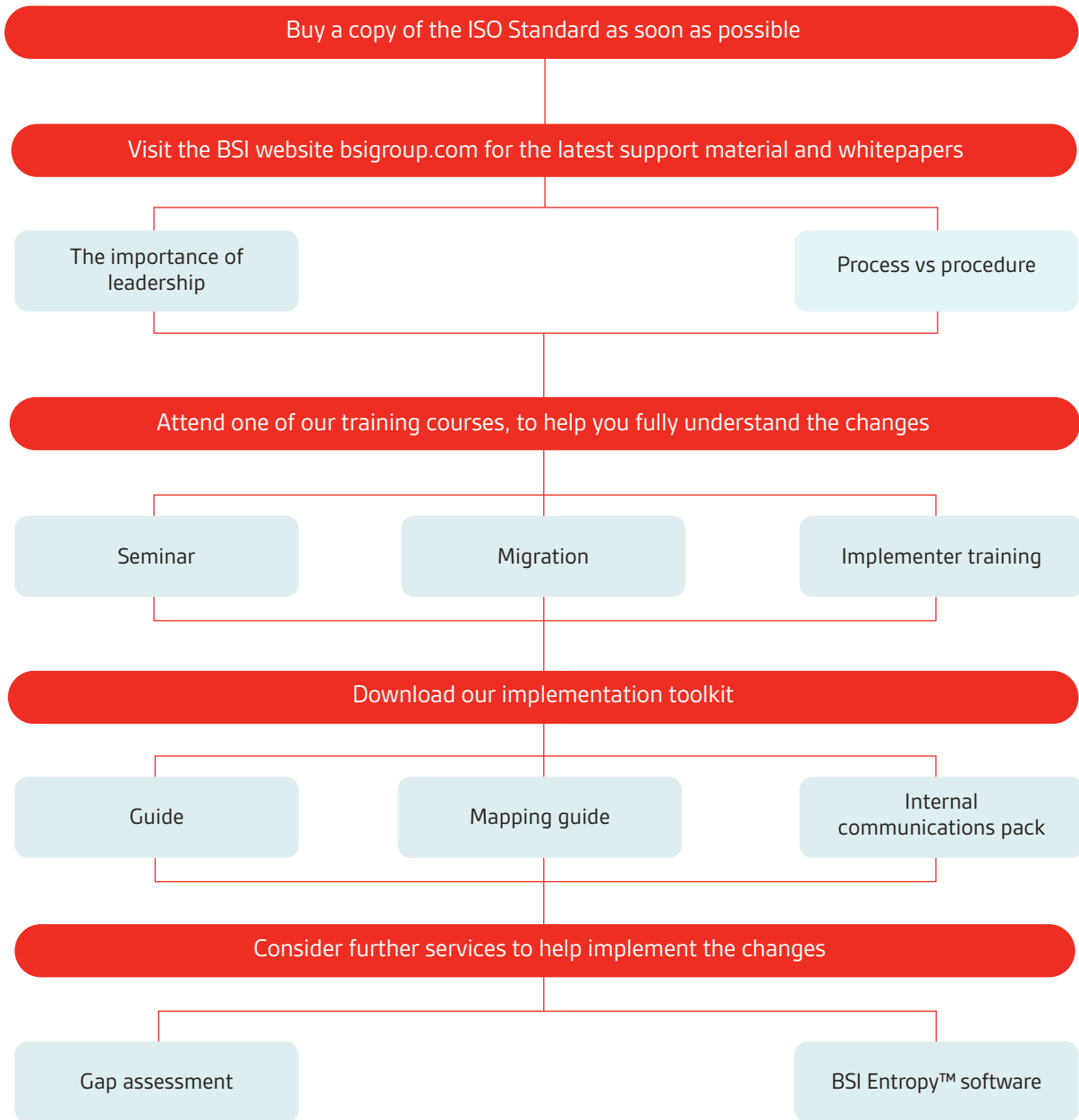
