Smart Industry Readiness Index (SIRI) Training Course and Examination

FAQs for Certified SIRI Training Course

1. What is the Certified SIRI Assessor Training & Certification scheme?

The SIRI Assessor Programme was established to formally recognize independent and neutral individuals who can professionally assess a manufacturing facility using SIRI and its accompanying frameworks and tools.

2. How can I become a Certified SIRI Assessor (CSA)?

You can enrol for the Certified SIRI Assessor Training Course and take the examinations by an Approved Training Provider, such as BSI.

3. What will I learn?

The Certified SIRI Assessor Training Course is designed to equip industry practitioners with the requisite industry knowledge and skills to become as SIRI assessor.

4. Who should attend?

Anyone involved in assessing organization's Smart Industry Readiness Index.

5. What are the pre-requisites?

You must have:

- Relevant degree in Science, Technology, Engineering and Mathematics (STEM)
- At least 3 years of job experience relating to advisory work and activities. It is recommended to have at least 300 hours of project advisory/consulting experience
- At least 5 years of job experience relating to the manufacturing sector
- 2 referees from manufacturing and/or advisory projects over the last 2 years

6. What is the duration of the training course?

The training course consists of 5 days (8hours/day, 1 hour lunch break) of virtual classroom training.

7. What will I gain?

Upon successful completion of attending the training course and passing the examinations, you will be awarded a certificate bearing the BSI and INCIT logo and registered formally on the SIRI portal managed by INCIT.



FAQs for Certified SIRI Training Examinations

1. When can I take the Certified SIRI Assessor Examinations?

It is strongly recommended to have at least 100 hours of self-study after attending the Certified SIRI Assessor Training Course before attempting the examinations.

2. What is the format of the examinations?

It consists of 2-parts, which are taken separately on different days.

- Theory (50 MCQ, 1 point each, 90mins)
- Practical (Case Interview with examiner, 100 points, 90mins)

3. What is the passing grade for Theory Examinations?

The passing grade need at least 25% out of the 50% weightage for Theory Examinations.

4. What is the passing grade for Practical Examinations?

The passing grade need at least 25% out of 50% weightage for Practical Examinations.

5. What is the mode of Theory Examination?

It is conducted virtually via an examinations portal to invigilate delegates for Theory Examinations.

6. What is the mode of Practical Examination?

It is conducted virtually with individual delegate being interviewed for the Case Study presentation during the Practical Examination.

7. What is the cost of the examinations?

The cost of the examination is SGD 2,250 per delegate. Price is exclusive of 8% GST.

8. What if I am unsuccessful in passing the examinations for the first time?

You can have multiple retakes by signing up for the next available examinations date and each retake is SGD 2,250 per delegate. Prices are exclusive of 8% GST.
